B Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Fargo in 1909 found two old stakes and pieces of elm roots and set a pipe surrounded with lime and sand and in 2005 Curtis PS#43048 recovered Fargo's pipe and placed a 5/8" iron with cap #43048 in the pipe and added a monument box. Recovered at this location was a 5/8" iron with cap#43048 in monument box, could not locate the 1/2" iron. Distance to E-6 compares with Fargo's distance 2647.92' measure vs. 2646.60' Fargo. Replaced cap#43048 with a Wexford County brass cap stamped: 390988, 16,17,20,21 and accepted the iron as a careful and faithful perpetuation of the position of the original corner being the Section corner common to sections 16, 17, 20 and 21 T21N-R12W.

c. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Placed Wexford County brass cap stamped: 39098, 16, 17, 20, 21, on existing iron in monument box. Corner is in the Northern Exposure campground $\pm 3'$ N. of road centerline and is Between lot 137 and lot 30
