(a) The term "public place" as used in this Chapter shall mean any street, alley, park, public building, any place of business or assembly open to or frequented by the public, and any other place which is open to the public view, or to which the public

"Public nudity" defined. Public nudity as used in this ordinance means knowingly or intentionally displaying in a public place any individual's genitals or anus with less than a fully opaque covering, or any female individual's breast with less than a fully opaque covering of the nipple and areola, for payment or promise of payment.

## 20.652 - Acts prohibited.

Sec. 9.62. No person shall:

- (1) Commit an assault, or assault and battery on any person;
- (2) A person who is intoxicated in a public place and who is either endangering directly the safety of another person or property or is acting in a manner that causes a public disturbance.
- (3) Engage in any indecent, insulting, immoral, or obscene conduct in any public place;
- (4) Discharge any firearm, air rifle, air pistol or bow and arrow in the City, except when lawfully acting in the defense of persons or property or the enforcement of law or at a duly established range, the operation of which has been approved by the City Council;
- (5) Fire, discharge, display or possess any fire works except of the type and under the conditions permitted by Chapter 39 of the Penal Code of the State of Michigan as amended by Act 242 of the Public Acts of 1949;
- (6) Engage in the peeping in the windows of any inhabited place;
- (7) Beg in any public place;
- (8) Swim or bathe in any public place without wearing proper apparel;
- (9) Utter vile, profane or obscene language in any place;
- (10) Make any immoral exhibition or indecent exposure of his or her person;
- (11) Print, engrave, sell, offer for sale, give away, exhibit or publish or have in possession for any such purpose any obscene, lewd, lascivious, indecent or immodest book, pamphlet, paper, picture, cast statuary, image or representation or other article of an indecent or immoral nature, or any book, paper, print, circular or writing made up principally of pictures or stories of immodest deeds, lust, crime, or exhibit any such articles in the view of any passer-by;
- (12) Wilfully destroy, remove, damage, alter or in any manner deface any property not his own, or any public school building, or any public building, bridge, fire hydrant, alarm box, street light, street sign, traffic control device, parking meter, or shade tree belonging to the City or located in the public access of the City, or mark or post handbills on, or in any manner mar the walls of any public building, fence, tree, or pole within the City, or destroy, Start of Theddle with any property

- belonging to the City, or remove the same from the building or place where it may be kept, placed, or stored, without proper authority, or disturb, tamper with, disconnect or damage any City water meter without proper authority;
- (13) Insult, accost, molest, or otherwise annoy, either by word of mouth, sign, or motion, any person in any public place;
- (14) Engage in any disturbance, fight, or quarrel in a public place;
- (15) Collect or stand in crowds, or arrange, encourage, or abet the collection of persons in crowds for illegal or mischievous purposes in any public place;
- (16) Jostle or roughly crowd persons in any street, alley, park, or public building;
- (17) Loiter on any street or sidewalk or in any park or public building or conduct himself in any place so as to obstruct the free and uninterrupted passage of the public;
- (18) Play any ball game in any public street or sidewalk or otherwise obstruct traffic on any street or sidewalk by collecting in groups thereon, for any purpose;
- (19) Engage in any act of prostitution;
- (20) Attend, frequent, operate or be an occupant or inmate of any place where prostitution, gambling, the illegal sale of intoxicating liquor, or where any other illegal or immoral business or occupation is permitted or conducted;
- (21) Engage in prostitution, gambling, the illegal sale of intoxicating liquor, or any other illegal or immoral business or occupation. Proof of recent reputation for engaging in prostitution, gambling, illegal sale of intoxicating liquor, or other illegal or immoral occupation or business shall be prima facie evidence of being engaged or occupied therein;
- (22) Solicit or accost any person for the purpose of inducing the commission of any illegal or immoral act;
- (23) Knowingly transport any person to a place where prostitution or gambling is practiced, encouraged, or allowed for the purpose of enabling such person to engage in any illegal or immoral act;
- (24) Keep or maintain a gaming room, gaming tables, or any policy or pool tickets, used for gaming; or knowingly suffer a gaming room, gaming tables, or any policy or pool tickets to be kept, maintained, played or sold on any premises occupied or controlled by him;
- (25) Disturb the public peace and quiet by loud, boisterous, or vulgar conduct;
- (26) Permit or suffer any place occupied or controlled by him to be a resort of noisy, boisterous, or disorderly persons;
- (27) Obstruct, resist, hinder, or oppose any member of the police force, or any peace officer in the discharge of his duties as such;
- (28) Wander about the streets, either by day or night, or loiter in any public building, without any lawful means of support or without being able to give a satisfactory account of himself;
- (29) Prowl about any alley or the private premises of any other person in the nighttime, without authority or the permission of the owner of such premises;
- (30) Spit on any sidewalk or on the floor or seat of any public carrier, or on any floor,
