## **Comments from Stakeholders**

No comments were received regarding the 2017 YOE compartments.

## **Compartment 12 (Stand examiner – Patrick Mohney)**

Changes made at compartment review:

- Stand 36 – Add comment no retention due to regeneration concerns, small size.

## **Compartment 22 (Stand examiner – Thomas Barnes)**

No changes made at compartment review.

## **Compartment 63 (Stand examiner – Patrick Potter)**

Changes made at compartment review:

- Stands 2 and 33 – Change proposed start date to 1/01/16.
- Stands 101 and 104 – Prescription for phragmites spray treatment.

### **Compartment 69 (Stand examiner – Matt Foster)**

Changes made at compartment review:

- Adjust base features in Stands 89 through 91 and elsewhere to remove the water segments so that water coverages are accurately mapped.
- Stands 138 and 142 – Add retention outside of the treatment area (3-10%).

### **Compartment 185 (Stand examiner – Joan Charlebois)**

Changes made at compartment review:

- Stand 2 – Change the boundary along the south and east treatment lines to reflect harvest of the hilltop only. This map should be reposted with the Record of Decision.

### **Compartment 192 (Stand examiner – Joan Charlebois)**

Changes made at compartment review:

- Stand 45 – Clear cut with reserves (3-10%) and a focus to reduce visual impacts along the trail.
- Stands 59 and 66 – Implement specific recreation protection spec's from the Recreation Specialist.

### **Compartment 198 (Stand examiner – Joan Charlebois)**

Changes made at compartment review:

- Stands 56, 156 and 454 – Add recreation protection spec's.

### **Compartment 207 (Stand examiner – Patrick Mohney)**

Changes made at compartment review:

- Stands 21, 50, 55, 72, 400, 402 and 403 – Add recreation protections spec's to bring attention to the treatments to recreation users. Specific spec's should be written to post warning signs, protect all signs/posts and to return the trail to pre-treatment conditions no matter the season.

Changes made at compartment review:

- Stand 405 – Prescription for Wildlife Opening Management. The map should be reposted with the Record of Decision.

Changes made at compartment review:

- Stands 8 and 108 – Change proposed start date to 1/01/2016; include fuel breaks around the campground. Remove site condition.
- Fuel break harvest west of Staley Lake Road proposed start date should match KW harvest.
- Stands 8, 60 and 108 – Add comment for protection of recreation facilities.
- Stands 1, 3, 5, 9, 15, 17, 20, 21, 60 – All KW harvest start dates to be changed to 10/01/19 and replanted 2024.

- Stand 38 – Accept lower stocking; if Military wants red pine replaced within the stand, we would be willing to replant at Military expense.
