Comments from Open House and E-Mail

There were 17 visitors signed in at the Open House on July 16, 2013 at the Gladwin Field Office. There were 5 visitors signed in at the Open House on July 17, 2013 at the Redding Town Hall. There was one e-mail comment from William Roth concerning ORV and mud bogging damage as well as illegal trash dumping on State Forest Land around Forest Lake, Alger, Michigan. There was an e-mail comment from Matt Mates in support of forest management for early successional species for grouse, woodcock, songbirds and other wildlife.

Changes to be made: *(This is the record of official changes to the maps and database).*

Compartment 18

Stand 7 – Move south portion of treatment boundary north.

Stand 8 – Add a final harvest with reserves. Add a next step to interplant red pine if natural regeneration is not successful. Focus retention on southern portion of stand and along pathway.

Add pathway to final map.

Stands 73, 81, 97, 82, 84,40,45,52,54,32,24 and 19 add site conditions for inaccessible.

Stand 35 – Pathway is seasonally underwater. Submit a trail proposal to re-build bridge or re-route trail.

Compartment 41

Stand 151 – Change to group selection.

Compartment 69

Note that most of compartment is Bentley Marsh

Stand 78 – Added as an SCA unique site.

No changes.

Compartment 99

Correct road layer and repost .pdf. Roads to close are still shown on the map.

Stand 98 – Change to selection harvest in prescription. Remove reference to clearcut.

Compartment 123

Mr. Roth's comments about road closures will be addressed by using tops, etc. from timber sale to close some roads, according to road closure plan for this compartment. His main concerns were in comp 124 and these will be addressed during sale administration for the sale in that compartment.

Add that Out of YOE sales in compartment 124 are actually continuation of sales in adjacent compartment 123. These are treatments 73124050_Thin and 73124030_Thin

Inventory will reflect transfer of boat access site to PRD.

Narrative – Add fisheries concerns.

Add site conditions to all of stand 97 and part of stand 104.

Compartment 140

Stand 158 - Need to add a factor limit or treatment.

Stand 107 – Need to re-digitize site condition in stand 102 which will remove the limiting factor in stand 107.

Stands 75,76,85,66, 241, 251, 257 – change to clearcut with reserves.

Stand 93 – Add note to follow normal BMPs and add a hunter walk in trail.
