Compartment specific changes made during the Compartment Review:

Compartment 009 (Stand Examiner – Rick McDonald)

- Stand 26 – Correct post review packet, so treatment shows on report.
- Stand 37 – Add trail protection specs.

Compartment 038 (Stand Examiner – Greg Rekowski)

- Stand 37 – Update comments to remove '2019' as year of burn.

Compartment 017 (Stand Examiner – Rick McDonald)

- Stand 18 – Add next step herbicide for invasives. Add next step prescribed burn. Add 'Cut First' spec. Change MO to upland shrub.
- Stand 27 – Establish retention islands around advanced desirable regen. Modify prescription description 'Initial treatment *may...*' Add next step herbicide for invasives.
- Stand 13x – Add next step of roller chopping. Add planting of oak, hawthorn and other mast species as next step treatment.
