Comments from stakeholders received prior to Compartment Review

Open house was held at the Shingleton field office on September 12, 2024, with 2 non-DNR attendees. No public comments received regarding treatments.

Compartment specific changes made during Compartment Review

Compartment 12 – Wilson

- Stands 39 and 40 – Drop 5C site condition. Add comment to each stand to follow natural pine guidance.
- Stand 39 – Add site condition for survey needed

Compartment 22 – Petrelius

- Stand 59 – Remove factor for delay treatment and add site condition for survey needed.

Compartment 41 – Petrelius

- No changes.

Compartment 52 – Petrelius

- Stand 36 - Drop 5c site condition. Maintain higher BA closer to the Stutt creek.

Compartment 62 – Clark

- No changes.

Compartment 70 – Petrelius

- No changes.

Compartment 72 – Tuovila

- No changes.

Compartment 112 – Kentner

- No changes.

Compartment 118 – Kentner

- Stand 75 – Change to 20 BA to follow natural pine guidance.

- Stand 16 and 28 – Change MO to natural jack pine. Add next steps to scarify and seed.

Compartment 156 – Molin

Compartment 159 – Kentner

- No changes.

Compartment 161 – Molin

- Stand 8 – Leave cedar and hemlock.
- Stands 12, 52, 73, 77 – Drop treatment.
- Compartment 160 Stand 65 – Terminate treatment.

- Stand 15 and 17 - Drop treatment.

Compartment 107 – Clark

- No changes.

Compartment 125 – Wheeler

- Stand 2, 3, 9, 50 and 55 – Treatments were read in during the meeting into the record.

Compartment 84 – Tuovila

- Stands 4 and 5 and Compartment 85 - Stand 78 (out of entry year of entry) – add oak wilt restrictions to treatments.
- Stand 47 – change active treatment to first year regen survey; change 3rd year regen – to 10/1/25.


Compartment 93 – Tuovila

- Stand 90 – add comment to keep operations out of adjacent wildlife openings except for where decking is needed. Minimize decking occurring in the opening and use remediate damages spec.

Sucker River FD Sea Lamprey Weir Treatment

- Discussed the proposal for the Weir.
- Collaboration with Fish and wildlife for Sea Lamprey barrier.
- Fisheries will own and operate this structure.
- Project to be completed by fall 2025.
- Installing lift gate (weir) - Seasonal lifts depending on spawning.
