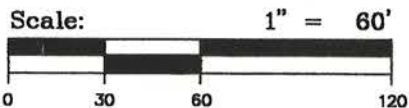


SPACE RESERVED FOR REGISTER OF DEEDS

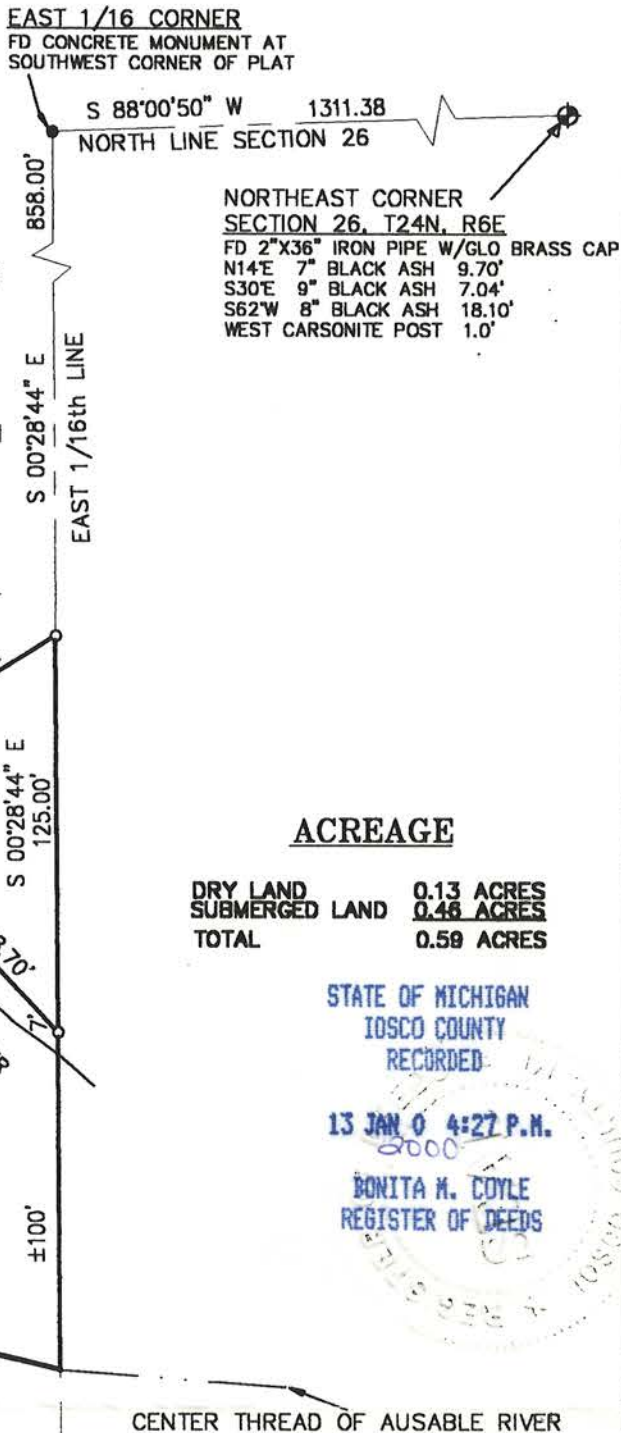


U.S. Government Land Purchase

LAND DESCRIPTION: A parcel of land situated in the Township of Oscoda, County of Iosco, State of Michigan, and described as follows:

Part of the Northeast 1/4 of Section 26, Town 24 North, Range 6 East, Michigan Meridian, more fully described as: Commencing at the Northeast corner of said Section 26: thence South 88°00'50" West along the North line of said section, 1311.38 feet to the East 1/16th line of said section; thence South 00°28'44" East along said 1/16th line, 858.00 feet to the Point of Beginning; thence continuing South 00°28'44" East along said 1/16th line, 125.00 feet to an intermediate traverse line along the shore of the Au Sable River; thence North 42°56'38" West along said traverse line, 108.70 feet; thence North 58°06'24" East, 85.98 feet to said East 1/16th line and the Point of Beginning. The sidelines of said parcel extend to the center thread of the Au Sable River. Said parcel contains 0.13 acres of dry land and 0.46 acres of submerged land, more or less.

SUBJECT TO all agreements, covenants, easements, right-of-ways, reservations, and restrictions of record, if any.
