Part B: Surveyor's Report on Perpetuation, Restoration, Reestablishment, or Monumentation of Corner

Found 1/2" Iron rod \pm 5' North of centerline of asphalt road. Found 3 witnesses from the 2003 survey by Quaine. The distance from B05 of A05 as shown by Granger matches a SPM distance from A05 of C05 but measures 4.12 feet longer than shown on his survey. Found iron is 4.48 feet East and 4.60 feet North of a SPM position. No monument found at the Granger distance. Distances East and West match the 2003 survey within reasonable tolerances. Accepted found iron as the best available evidence of the position of the original Government corner. Removed 1/2" iron and set standard County Monument.

Part C: Field Evidence of Perpetuation or Monumentation of Corner

Set 5/8" x 36" iron rod with 3 1/2" aluminum cap marked "Remonumentation Corner" "2020 47947"

North 33.00' found concrete monument.

N40E 55.96' set nail in 26" W. Pine

S30W 40.23' set nail in 16" Maple

N44W 47.25' set nail in 32" W. Oak
