Dear Forest Neighbor:

This letter is to inform you that a survey will be performed this fall to delineate the boundary between the Michigan DNR OR National Forest system and private land in Sections XX, XX and XX, Township XX North, Range XX West, NAME Township, NAME County, Michigan. During the course of this survey, it may be necessary to utilize existing trails and roads within the work area and have access across private lands adjacent to the Michigan DNR OR National Forest. I would be interested in evaluating any information you may have that will aid us in determining the location of the common boundary lines. If you have copies of any previous boundary survey drawings or any other historical survey data that may be pertinent to this project, please give me a call at XXX-XXX-XXXX or send copies via email to XXXXXXXX@michigan.gov or to my attention at the address below.

While performing this survey it will be necessary for us to make measurements around the areas mentioned. After measurements are made and the location of the property lines determined, corner monuments will be placed and the lines will be cleared of brush and marked with carsonite posts driven into the ground. Trees within 3 feet on the Michigan DNR OR National Forest side of the property line as well as line trees will be blazed. The blazes will be painted red. At all property corners, we will need to select 3 to 4 reference objects to preserve the corner location for future use. The reference objects utilized are typically trees, one in each quadrant (Northeast, Southeast, Southwest, and Northwest). It may be necessary to utilize trees on private land as reference objects and we are asking your permission to use (typically) no more than 1 tree on your property. Once the trees are selected it will be necessary for us to drive a nail in the side of the tree at its base for measuring purposes and then placement of a tag on the tree that will list the direction and distance to the corner position. These line markings and monuments are equally important to us as neighbors, and you are invited to maintain these through marking, re-painting and brushing in the future.

Dear Forest Neighbor,

This letter is to inform you that a survey may be performed within the next several months to delineate the boundary between National Forest system and private lands within Sections 10, 13, and 22 of T16N, R12W, Home Township, Newaygo County. During the course of this survey it may be necessary to utilize all existing trail roads within the work area and have access across private lands adjacent to the National Forest. I would be interested in evaluating any information you may have that will aid us in properly determining the location of the common boundary lines. If you have copies of any previous boundary survey drawings or any other historical data that may be pertinent to this project, please forward copies to my attention at the address above.

While performing this survey it will be necessary for us to make measurements around the sections mentioned above. During the course of making these measurements, it may be necessary to clear lines of sight on private land, however, no trees larger than 6 inches in diameter shall be cut. After measurements are made and the location of the property lines determined, corner monuments will be placed and the lines will be cleared of brush and marked with orange fiberglass posts driven into the ground. Trees within 3 feet on the National Forest side of the property line as well as trees on line will also be blazed and painted red. At all property corners we will need to select 3-4 reference objects to preserve the corner location into the future. The reference objects utilized are typically trees, one in each of the different directional quadrants (North, South, East, and West). It may be necessary to utilize trees on private land as reference objects and we are asking your permission to use typically no more than 1 tree on your property. Once the trees are selected it will be necessary for us to drive a nail in the center of the tree at its base to make a measurement from and then place a tag on the tree that will list the direction and distance to the corner location.
