

Part B: Surveyor's Report on Perpetuation or Monumentation of Corner(s)

Fnd. no evidence of original corner or references. Found 1/2" bar & PS Cap #18660 by Donald E. Marlatt. Note this bar & cap is on the Sec. line but found to 1.76' South of equal distance. Three trees had spikes with no PS tags.

Set 4" dia x 36" concrete monument with Co. Re-mon. cap on top by S.P. method.

Accepted by the peer group as the a careful and faithful establishment of the position of the original corner on 08-25- 2017.
