On May 5, 1931, the Institute received from R. Binder Co., of Eattle Greek one specimen in the flesh, unpreserved, and cleaned, of the rainbow trout, <u>Salmo gairdnerijirideus</u>. The fish was in the so-called "steelhead" phase, which means that it had been caught either in a large lake or in the ocean, for it is only in such waters that these fish become of this appearance. It is a fish of the same species as runs into our streams from the Great Lakes, assuming than the markings which call forth the name "rainbow trout".
