Comments from Stakeholders

Compartment 7 (Stand examiner – Darrick Coy)

No changes made at compartment review.

<u>Compartment 34 (Stand examiner – Jeff Autenrieth)</u>

Changes made at compartment review:

- Stand 48 Add treatment for trench and plant to Red Pine in southeast corner of the stand.
- Stand 77 Refer to Elk Management Plan and promote a mixed stand in next step treatment.

<u>Compartment 39 (Stand examiner – Richard Barber)</u>

Changes made at compartment review:

- Stand 47 Check treatment type (marked thinning versus systematic thinning).
- Stand 67 Add comment stating that prescription acres will likely fall short of <25% stand acres.
- Stand 51 Change treatment management objective to current cover type.
- Paige Perry will provide stand list for comments regarding ORV sale specs (Stump Heights)
- Stand 29 Change managed site to plantation, add treatment for planting

<u>Compartment 41 (Stand examiner – Jeff Autenrieth)</u>

Changes made at compartment review:

- Stands 16, 33, 41, 42, 61 Add Special Conservation Area (SCA) Unique Site, describe stand characteristics and conservation values that are being protected; soil productivity, stand structure, and existing mid – late succession stages, recreational, scenic, and intrinsic values are being emphasized for long-term management. The stands have had passive management in the past and will be continued. Change compartment narrative to include High Country Pathway, remove ORV/snowmobile trail comment.
- Stands 54, 55, 64, 34, 44 Code for SCA removal; no unique values for these stands. ***
- Stand 75 Remove comment in treatment regarding Potential Old Growth (POG), specify to use legacy trees as leave trees.
- Stand 87 Change SC to 5C
- Stand 39 Add note to treatment specifications to avoid damage to the trail.
- Update roads and base features to address Oxbow Road type and add missing forest roads

- Stands 15, 25, 33, 63, 80, 27, 34 Specific trail comments need to be added to the treatments layer; Paige Perry will provide guidance.

<u>Compartment 82 (Stand examiner – Richard Barber)</u>

Changes made at compartment review:

Add symbols for non-motorized trails.

Compartment 96 (Stand examiner – Kirby Osvold)

Changes made at compartment review:

- Stand 2 Change to no retention, as only a portion of the stand is being harvested (remainder of the stand will serve as retention).
- Add Opportunistic Field Survey (OFS) point (locked) for archaeological site and refer to it in treatment comments for stand 60.

Compartment 99 (Stand examiner – Darrick Coy)

Changes made at compartment review:

• Stands 1, 4, 10, and 17 – Add proposed start date for regeneration surveys and change managed site to Natural Regeneration.

Compartment 122 (Stand examiner – Richard Barber)

Changes made at compartment review:

- Stands 26, 31, 32 Add comment to note that treatment boundary has been modified to buffer riparian area.
- Stand 32 Expand treatment to L type boundary (remove buffer).

Changes made at compartment review:

• Stand 56 – Add rabbit habitat specifications to the prescription.

- Stand 6 Delay treatment until October 1, 2020 for portion surrounded by non-motorized trails. For remaining portion, ensure two year contract with ne extensions.

- Add Lake Sixteen Ecological Reference Area (ERA) comments to the compartment narrative.
- Add trails symbology for non-motorized trails.
