Compartment specific changes made during the Compartment Review:

Compartment 006 (Stand Examiner – Kevin Elhert)

- Stand 24 – Reshape site condition boundary.

Compartment 028 (Stand Examiner – Kevin Elhert)

- Stand 10 and 17 – Move Comment 'If natural regen fails...' over to Acceptable Regeneration.

Compartment 071 (Stand Examiner – Joan Charlebois)

- Check with RAS regarding Survey Corners along Stand 3.
- Follow EMR CCA guidelines.

Compartment 173 (Stand Examiner – Tom Barnes)

- Stand 29 – Modify Acceptable Regeneration to 'A minimum component of 20% oak regeneration is the goal'.

Compartment 177 (Stand Examiner – Joan Charlebois)

- In all oak clearcuts – Add a percentage to acceptable oak regeneration.
- Reclassify bermed roads as closed.

Compartment 183 (Stand Examiner – Dan Heckman)

- Stands 9, 23, 25, and 14 – Reshape treatment due to EMR, excluding Stand 14. Create separate treatments for Stand 23 and 25.

Compartment 212 (Stand Examiner – Matt Foster)

- Stand 9 – Add clearcut treatment, leave portion along Stand 411 for retention.
- Stand 26 – Expand thinning treatment to Stand 54 in Compartment 211.
*Seek stakeholder approval for treatment.

Compartment 221 (Stand Examiner – Tom Barnes)

- Stand 23 – Change natural regen to 2 years post-harvest check.
- Stands 6 and 17 – Add clearcut (due to potential disposal of land per Industrial Park MOU).

Compartment 241 (Stand Examiner – Joan Charlebois)

- Stands 12 and 13 – Drop chipping spec in case of Plan B planting operation.

Compartment 266 (Stand Examiner – Tom Barnes)

- Stand 55 – Add harvest treatment, with soft factor need survey. Declare surplus, recommend disposal.

Compartment 282 (Stand Examiner – Matt Foster)

- Pursue optimal road access for KW lands in Section 21.
- Stand 44 – Declare surplus.
