 Stand 19 – No changes to treatment. However, add 5E treatment that doesn't currently have a 3A. Add soft factor, 2i, site condition with comment for MNFI survey needed. After survey is added, will buffer 100 feet with 3A.

# County Line Hardwoods

C108 (L. Livermore)

- Stand 39 Change representative age class.
- Stand 54 add comments: may be possible to treat in the future.

C041 (A. Livermore)

 Stands 10, 30 and 40 – Drop harvest treatments inside ERA but keep burn treatment.

- Stand 42 Change to seed tree with retention leave 10-30 BA of evenly spaced and healthy Red and White Pine. Leave Hemlock.
- Stand 37 Change to clear cut with retention; retention will be on edges and steep slopes. Natural regeneration. Intermediate regen check. If natural regen fails, hand plant red pine without furrows. Final treatment regen may change.
- Stand 56 Update inventory and site condition with new data.

# Chris Brown & Connor Lakes ERA Plan

 Change wording under the threat assessments, intermittent wetland, Conner lakes bullet, 3<sup>rd</sup> sentence, to read Protect the wetland WITH an upland buffer of pine forest.

# Two Hearted Headwaters

**C021** (Tokar)

• Stands 45, 50 – add treatments to harvest (outside of 100' buffer zone). Crown thinning. Follow natural rivers plan. Try to minimize harvest of aspen. Acreage may change.

# Whitefish Vermillion Point

C059 (L. Livermore/Payment)

- Stand 26 [additional treatment where fire occurred (8.5 acres)]: clear cut with retention with 100-foot, no-cut buffer along wetland area. Next steps, scarification. Acceptable regen is jack pine with other species. If scarification fails, consider planting or seeding jack pine.
- In the burnt area of Stand 110 and 112 Retain 10-20 BA of red and white and retain all oak where present. Remove 5C site condition from fire site; start date of 10-27-21.
- Change start date of 112 to 10-27-21.
