• Compartment 157, Stands 47 and 53 – Clumps along trail (ski, horse, bike, hike) instead of harvest 1 side, leave intermittent clumps along trail.

 Aspen and tag alder regeneration is vital for both grouse and woodcock as well as multiple other species. Good management is the key.

- Stands 55 & 83 Do pre-burn and post-burn monitoring. Add monitoring treatment for burn and subsequent burn.
- Stand 59 Add next step of oak planting.

- Stand 49 Apply visual management for adjacent campground.
