Comments from Stakeholders

- Stand 15: add "small acreage" (<3%) retention reason.
- Stand 12: add leave hemlock if it exists.
- Stand 19: add leave some scattered large diameter trees of various species.
- Stand 30: add leave all hemlock and retain species diversity.
- Stand 36: add leave all hemlock.
- Stand 47: add leave all hemlock and cedar.
- Stand 64: change "during a dry summer" to "cut after October 1st."
