- Pretty Lakes ERA plan was approved with the following changes.

Changes made at compartment review:

- In beginning of plan, on page 2 add bullet with Keith Kintigh's clarifying sentence about ERA boundaries, stopping after "consult with specialist".
- Management Objectives section: Add Keith K. clarifying sentence.
- Management Actions section bullet number 4: Change to read "maintain natural plant species."
- Management Actions bullet number 6: Remove "former" from the sentence, "Rehabilitate former fire lines as applicable."
- Under Management Actions: Put patterned fen bullets in a separate heading.
- Management actions bullet Number 13: add word "immediately". "Avoid creating new roads immediately adjacent to ERA."
- Management actions second to last bullet: Add "if applicable." "If applicable, use periodic burning..."
- Management actions last bullet: clarify "only west of road." "Where forest regeneration is found to be inadequate west of the road".
- Monitoring section: Add clarifying statement.

C031 (Stand examiners – Don Kuhr/Keith Magnusson)

- There will be further discussion to clarify the differences in interpretation in these plans.

Changes made at compartment review:

- Stand 10: Change to clear cut with retention. Add retention patch (5E). Remove comment about "no retention needed."
- All treatments: no chipping, winter harvest and leave hemlock if it exists.

Tahquamenon River Basin Wetlands MA:

C120 (Stand examiner – Jennifer Burnham)

- Discussion regarding deer wintering complex management plans, and the need to analyze the amount of functional cover.
- Discuss interpretation of white versus black spruce as functional cover.

Changes made at compartment review.

- Stand 23: Drop treatment.
- Stands 14 and 6: Leave all cedar, unless a few incidental cedars are cut for maneuverability. Where cedar density precludes cutting of other species, leave as a retention pocket. Leave all pockets of sub-merchantable balsam fir.
- Place a high dollar value on cedar, to discourage incidental harvest.

- Management Objectives section: Add Keith's clarifying sentence.
- Management actions section bullet 4: Add "Consider" at the beginning and "fuel and weather conditions" at the end.
- Management actions section bullet 7: change to "Maintain appropriate buffer of natural vegetation surrounding the muskeg to reduce the threat of negative hydrological impact".
- Management actions section bullet 7: Remove sentence: "Minimize clearcuts adjacent to the ERA's with existing significant deer browse pressure."
- Management actions section "Vehicular traffic" Bullet: remove wording "adjacent to ERA."
- Management actions section last bullet: add "as opportunities arise."
- Monitoring section: Add clarifying statement.

Wildlife Planting (Sitar)

• Discuss planting of different species in different locations for wildlife.

Changes made at compartment review:

- C 071 Stand 17: Red Osier dogwood planting.
- C 077 Stand 12: Plant clover in trail.
- C134 stand 23; C107 stand 32; C108 stand 3; C127 stand 65; C097 stands 15 and 37: Plant Apple trees in openings.
