• Stand 21: Add next steps for planting wildlife trees and shrubs.

Use normal trail protections, keep open and sign during seasons.

Changes made at compartment review:

• Stand 34: Add 5C site condition.

County Line Hardwoods MA

• Use snowmobile trail protections. No issues with ORV trail.

Changes made at compartment review:

Stand 43: Remove site condition.

Drummond Island MA

- Noted that the compartment contained ERAs that are part of the ERA plans to be reviewed.
- Normal trail protections for snowmobile and ORV.

- If winter harvest is needed: use snowmobile trail protections, keep all trails open, sign for timber sale operation.

- Stands 4, 7, 12: Add treatment of "clearcut with retention". Leave Cedar and Oak. Add comment "Treatment may be modified to promote successful regeneration". Check HAL comments. Dave will add wildlife comments for purchased lands. Site condition for survey.
- Stand 3: Add treatment "single tree selection", with the same comment about regeneration as for stands 4 & 7. Dave will add wildlife comments for purchased lands. Site condition for survey.
- Stands 2, 5, 8, 10: Change site condition to 5A. Add comments about difficulty of obtaining regeneration after harvest.

• For treatments by snowmobile trails: use normal trail protections, keep open, leave snow base.

Changes made at compartment review:

- Stands 46 and 59: remove site condition.
- Stand 69: Remove comment "talk to wildlife". Add comments that the south side
 of the road will be winter cut, and the north side of the road is not winter cut only.

- Stands 10, 16, 26, and 31: Change start date to 10/3/18.
- Stands 1, 3, 13: Add 2B site condition.
- Stand 21: Add 3H site condition.

Changes made at compartment review:

- Stand 4: Add treatment "clearcut with retention". Treatment size may vary. Follow BMP guidance based on stream classification (300' for trout stream).

- Discuss Walther's research treatments.
- Discuss proposed horse campground.

Changes made at compartment review:

- Stand 1: Remove site condition.
- Stand 18: Split and adjust the BA. Remove 5C site condition.

No issues with trails.

Changes made at compartment review:

- Stands 35, 37, 45, 52, and 61: Add survey site conditions.
- Stand 48: Add site condition to the portion of the stand without the treatment.

Changes made at compartment review:

• Stand 41: Place ribbon on ATV trail before harvesting stand. Use normal trail protections.

• Use normal snowmobile and ORV trail protections. If cut in winter, mark ORV trail before cutting begins.

• All "monitor" treatments: Fix start date to follow guidance.

North Rudyard MA

Discussion of comments from individuals:

Use normal snowmobile trail protections if harvesting near trail.

Changes made at compartment review:

• Stands 5 and 7: Add treatment "clearcut with retention". Leave retention area in the north between stand 10 and the 3B area, connecting them.

Changes made at compartment review:

• Stand 79: Add treatment for "clearcut no retention".
