Comments from Stakeholders

Public comment was received - not within the treatment areas.

Compartments Under Review:

Compartment 13 – Stand Examiners Bob Burnham/Steve Tuovila

Treatment 41013063-Cut - Remove the following wording: "Designate the dense areas of red pine as areas for the slash to be removed; this may be roughly about 1/2 the stand acreage. These areas will be scarified or tractor/plow work to prepare a red pine seedbed."

Address 'Next Step to Create' for 4101318-Monitoring

WLD to add comments in 'Draft Treatment notes' to explain opportunities regarding road reclamation and seeding

Change start date to 10/14/2022 for all treatments in this compartment

Stand 32 - Leave some larger diameter white pine

Stands 23, 26, 33 - Incorporate some white pine and red pine in line work, leave cedar, if present.

Stand 5 - Remove the following - 'Leave up to a total BA of 10 between the red and white pine for structural diversity, wildlife, and for potential seed source to supplement the current regeneration'. Change to 'mark to incorporate structural diversity throughout the stand for wildlife considerations.

Stand 4 - Remove the following - 'Pile all tops outside of treatment area to prep for scarification. Make the piles 4-5' tall to provide for rabbit habitat.' Remove all comments in the 'other comments' box. Acceptable regeneration should be red pine and other species found on site.

Stand 17 - update stand boundary to match the existing monitoring treatment

Add site condition for survey to all treatments in this compartment.

Stand 4 – Clear cut with no retention due to size. Do not cut oak and protect oak regen.

No harvesting during snowmobile season.

Tax reverted land – add pre-commercial thin.

Stand 25 and 42 – Maintain 200 ft buffer on the Fox and do not cut aspen within 300 feet of the Fox.

All G0 Stands in Compartment – Add treatment for Oak and shrubs planting for wildlife.

Compartment 114- Stand Examiner Scott Kentner
Treatment for fuel break will be moved to compartment boundary/private ownership line.

Compartment 136 – Stand Examiner Kyle Gould
Stand 90 – Buffer Fox River pathway 50 feet.

Compartment 141- Stand Examiner Bob Burnham
Pathway is not mapped correctly. Kentner to notify Holly Toohey (Lansing-GIS) to fix.

Compartment 157 – Stand Examiner Mario Molin
No changes.

Compartment 165 – Stand Examiner Bob Burnham/Steve Tuovila
Stands 10, 15, 19 – Change prescription to allow cutting white pine, except retain white pine over 24”.

Stand 33 – Drop treatment.

Compartment 169 – Stand Examiner Scott Kentner
Stand 35 and 36 - Add berm to Road Inventory. Add comment data cleanup - road does not exist.

Compartment 174 – Stand Examiner Bob Burnham/Steve Tuovila
No changes.

Compartment 179 – Stand Examiner Scott Kentner
Have Holly Toohey (Lansing-GIS) digitize the trail as a Stand.

Every Aspen Stand – wildlife to add next step treatment for Gem maintenance.

All stands - Change start date to 10/14/22.


Variance Request:
