



The information presented here represents some details relevant to land use, but this is not a complete list of all rules and regulations, and may not be as immediately updated as current legislation and rules. This product is not a legal notice, nor a complete collection of hunting regulations and laws. It is a condensed tool issued for convenience on this specific subject. PLEASE NOTE:

Because the St. John's Marsh Wildlife Area is part of the Great Lakes Coastal Marsh ecosystem, water levels fluctuate within the Great Lakes. During low water periods the marsh may become pools of very shallow water and mudflats. These periodic fluctuations create water and vegetation conditions that are healthy for the ecosystem, but may be a temporary inconvenience for recreational users. Entry into refuges will be permitted after the last waterfowl hunting day in December – dates will be posted at entry points on the Wildlife Area

Because of the difficulty for most people to get around under these conditions, the area will be posted "STATE GAME AREA -OPEN TO HUNTING." No special permit is necessary to hunt. State Land Rules and General Waterfowl Season Regulations will be in effect.

PARKING is a problem in the St.John's Marsh Wildlife Area. Please park in designated areas only.

THESE ACTIVITIES ARE PROHIBITED:

- 1. Hunting or shooting from any dike, road, trail, safety zone, or retrieving zone (such as near Refuge).
- 2. Entry into area posted "Wildlife Refuge" (from Sept. 1 to the end of waterfowl season) for any reason.
- 3. Use of non-toxic shot is required for all hunting it is unlawful to use or possess any shot, whether loose or loaded in shot shells, of a material other than Federally approved non-toxic shot, except single projectile loads.
- 4. Using an airboat, hovercraft, amphibious, all-terrain, or any other motor driven vehicle while in the area.
 - Outboard motors are permitted but must be operated at a no-wake speed.
 - Launching personal watercraft from any access site within the St.John's Marsh State Wildlife Area is prohibited.
- 5. Trapping in the area may required a written permit. No trapping in refuges until after the waterfowl season or as designated by area wildlife personnel. Contact the area office for detailed information.
- 6. Taking cans or glass bottles into the permit zones, or to possess or consume alcoholic beverages.
- 7. Other Rules and Regulations for the State Game Area may be posted in the area; look for additional signs or notices to insure you have a safe hunt.

CAUTION: Use care near all open water areas; some of areas may contain deep water, depending on season and recent rainfall.

<u>BE A SAFE HUNTER</u> - A safe hunter obeys laws governing hunting and boating, is alert to any conditions hazardous to personal safety of the hunter and others.

RULES AND REGULATIONS EXTRACTION

Under authority of Act 17, Public Act of 1921, the Commission of Natural Resources has made and adopted the following rules and regulations governing the use and occupancy of State lands, other than state parks and recreation areas, administered by or under the control of the Department of Natural Resources.

GENERAL RULES - It is prohibited:

- (1) To enter, use or occupy the lands for any purpose when they are posted against such entry, use or occupancy, as ordered by the Director of the Department of Natural Resources.
- (5) To move, remove, destroy, mutilate, or deface posters, notices, signs, or markers of the Department of Natural Resources or of any other agency of government.
- (8) To destroy, damage, or remove any state property, any living tree or shrub, planted grasses, or other vegetation without proper written permission. This provision does not apply to the picking and removal of mushrooms, berries, and other edible fruits and nuts and those wildflowers the removal of which is not made unlawful by statute.

IN STATE GAME AREAS IN ZONE 3, IN ADDITION TO ABOVE RULES - It is prohibited:

- 1. To camp between April 1 and October 1, except in areas specifically designed for such use.
- 2. To operate a self-propelled motor or mechanically driven vehicle on other than a designated established road open to the public, or a parking lot, or to park such vehicles more than 50 feet from an established road open to the public, or a parking lot designed for such use, without proper written permission.
- 3. To ride or lead a horse, other riding animal, or pack animal on, or to allow such animal or any animal-drawn vehicle to use or travel on any areas other than established public roads or trails designed for such use, without proper written permission.
 Proper Written Permission means a written permit issued by the Director of the Department of Natural Resources or a representative authorized by him to do so.
